**This campus improvement plan was developed collaboratively by the LSC (Local School Council), representing all campus stakeholders. All performance goals identified in No Child Left Behind legislation have been adopted by the district and are incorporated into this Improvement Plan.**

**The following funding sources support the objectives and strategies implemented to address identified student needs: Titles I, IIA, III, IDEA-B, Special Education, State Compensatory Education, Ed Jobs Grant, Instructional Materials Allotment, State Foundation Allotment, and local revenue. State fiscal stabilizations funds (SFSF) are vital to the academic success of students and programs at Eustace ISD.**

**Through a coordination and integration of federal, state, and local services, academic success of all students at Eustace Intermediate is maximized. Eustace ISD utilizes state Compensatory Education to support Title I school-wide reform. The campus total of \$50,399 State Compensatory Education allotment supports .75 FTE's.**

**Economically disadvantaged students encompass a high percentage of the student population; therefore, Eustace Intermediate School utilizes Title I funds to support the school-wide programs. The campus supports nine of the ten components of the school-wide program:**

## **NEEDS ASSESSMENT (TI 1)**

In the spring of 2011, Eustace Intermediate School conducted a needs assessment. 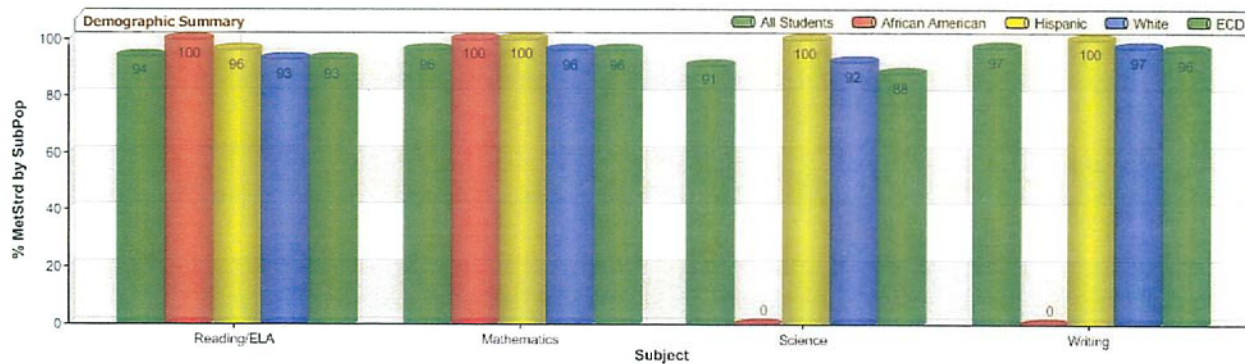
